Mr. Ellis introduced himself as a candidate for Circuit Court Judge in the Sixth Circuit (Pinellas and Pasco counties). Mr. Ellis stated he has been an attorney for 26 years and practices in three areas: family law, civil litigation, and elder law. Mr. Ellis said the primary election is August 28th and encouraged everyone to cast their vote.
