Honorable Mayor and City Council,

The City of Zephyrhills FY15 budget was passed on second reading on September 22, 2014 for a total amount of \$54,100,782. In accordance with Florida Statutes, the governing body of a municipality may amend its budget at any time within a fiscal year or within 60 days following the end of the fiscal year. Due to the many budgetary changes that have developed since the passage of this budget, we are bringing you a mid-year budget amendment. Most of the changes included have been discussed at City Council meetings during the year. The amendment increases the budget by \$24,445 to an new total of \$54,125,227.

This amendment includes a variety budgetary changes listed briefly as follows: two unbudgeted grants -Police Department Byrne Grant and Planning Department DEO Grant; Fire Station garage door replacement, fire engine light package replacement, a Public Safety Repeater project; donation and spending of funds collect by Youth Council for the Skate Park Project; timing differences between the prior year and the current year in budgeting for the Fire Station project (more was delayed to this year than anticipated); similar but reverse timing differences in the Library project (more was paid last year than anticipated); the receipt and use of donated funds to equip the new Library; the unanticipated delay in the FY14 Utility Department purchase of a crane truck; the use of earmarked reserves for vacation and sick time pay-outs for employees who have separated service; and general realignments with departments which by nature are generally larger in the Utility Fund as competing needs change. General contingency reserves in General Fund, Utility Fund, and Airport Fund decreased by \$1,770, \$102,806, and \$7,056 respectively. General Contingency reserves for Penny for Pasco Funds increased by \$181,632.
